<p><b>FEE</b>  <b>DISCOUNT RATE</b> on or before cut-off date:  <b>\$45 per person</b>  <b>FULL RATE</b> after cut-off date:  <b>\$55 per person</b>  <b>ADD-ONS</b> must be authorized by dRep prior to event day. Above rates apply. <b>NO WALK-INS ALLOWED.</b></p>	<p><b>The following items must be in our office by the cut-off date to receive the discount rate:</b></p> <ol style="list-style-type: none"> <li>1. Registration Form &amp; Contract</li> <li>2. Participant list</li> </ol> <p>(No phone registrations allowed. You may fax the above forms, but please call us at 415.225.0934 first. We do not have a dedicated fax line. Call if you need a detailed invoice for check requests. Fees and Medical Waivers are due at registration).</p>
<p><b>REGISTRATIONS</b>  This event is by pre-registration only. Registrations are non-cancelable and non-refundable. Registrations are limited to 75 participants and are confirmed on a first-come, first-serve basis. Registrations may be cut-off if quota is reached before the cut-off date. No children under the age of 7 will be allowed into any classroom.</p> <p><b>TEACHERS, STUDIO OWNERS &amp; MANAGERS</b>  To qualify for the following, all participants must be pre-registered with you on the same registration form by the <b>REGISTRATION CUT-OFF DATE.</b></p> <p><b>FREE TEACHER SPECIAL:</b></p> <ul style="list-style-type: none"> <li>• Bring 10-24 full paying students, assistant teachers or additional teachers and 1 teacher attends free.</li> <li>• Bring 25 or more full paying students, assistant teachers or additional teachers and 2 teachers attend free.</li> <li>• Teacher registration includes: Director’s Corner participation, one free CD of music for modern dance class and Director Reference Handbook filled with helpful hints and articles.</li> </ul> <p><b>ASSISTANT TEACHERS (same price as students)</b>  May dance in Director’s Corner classes only or may observe student classes. No dancing in student classes, please.</p>	<p><b>CONFIRMATION</b>  The primary contact will be notified upon receipt of required forms. An email will be sent as notification. Please print and bring with you to event registration as proof of receipt. If you do not receive a confirmation, contact us prior to event day at 415.225.0934 to ensure your participation.</p> <p><b>REFUND POLICY</b>  Once registered, NO REFUNDS will be authorized.</p> <p><b>PAYMENT PLANS</b>  For the underserved, we offer payment plans for an entire group. Please note that final payments must be received by <b>Fri, Jan. 2, 2009. NO EXCEPTIONS.</b> We do not want students to be discouraged from participating if they need additional time to raise funds. All payment plans must be authorized <b>BEFORE THE REGISTRATION CUT-OFF DATE.</b> No payment plans are extended after this date.</p> <p><b>CODE OF CONDUCT</b>  Dance Repertory reserves the right to refuse admittance to, or to remove anyone who is disruptive, unruly or displays rude, unacceptable behavior – to be determined at Director’s sole discretion.</p>
<p><b>OBSERVER TUITION = \$15</b>  Paid observers are allowed with paid students only and may observe student classes only. Pre-registration is recommended. (NO teachers, studio owners or managers may register as observers).</p>	<p><b>VIDEO RECORDING &amp; CAMERAS</b>  Video recording devices are prohibited at the event. No large camera equipment allowed. Small cameras accepted. Dance Repertory and/or San Francisco Dance Center will be recording classes and is the only organization permitted to videotape. We appreciate your cooperation.</p>
<p><b>DRESS CODE</b>  We ask that participants wear appropriate leotards, dance or sweat pants, jazz shoes, ballet slippers, lyrical sandals or bare feet. No jeans or black heeled tennis shoes that mark the floor, please. No jewelry and long hair tied up securely.</p> <p><b>FOOD</b>  Food in studios is prohibited. There is a 30-minute lunch break. Bring enough healthy food and snacks to last throughout the day. Eat a good breakfast, time is limited to eat between classes.</p>	<p><b>LARGE ITEMS IN CLASSROOMS</b>  No large items in the classrooms due to safety concerns. All dance bags, ice chests, etc. must fit along the classroom walls or outside in the halls. dRep has the authority to ask groups to leave bags in the hallways if needed. <b>DO NOT BRING ANY VALUABLES, YOU WILL NOT NEED THEM!</b> Monitors will be in the halls, but any lost or stolen items are not our responsibility. Have students bring what they absolutely must have (small amounts of money for goodies and apparel, a small lunch bag, etc.). We appreciate your cooperation.</p>
